The Contractor is REQUIRED to supply, deliver, install, test and commission the internal fiber cables. 3. The Contractor MUST have minimum 2 years in Installation, Testing, Commissioning and Maintenance of FTTH passive infrastructures. 4. The Contractor Must register with Construction Industry Development Board (CIDB) minimum grade G2 and National Institute of Occupational Safety and Health (NIOSH). 5. The Contractor Must register with Construction Industry Development Board (CIDB) under category E7 – Internal Telecommunication & E8 - External Telecommunication for FTTH passive Infrastructures. 6. The above FTTH deployment shall include all necessary materials, accessories, peripherals, labelling etc. to reflect a complete installation, documentation, testing and commissioning. 7. The scope of works covers Fiber Cabling Works (fiber cable pulling, fusing splicing works and testing), supply & install, test and commission all necessary materials/accessories. 8. The deployment MUST comply with the timeline as per the project schedule indicated in the tender document.
